THIRD PARTY FUNDING: A first for Malaysia but a leap for Islamic Investors in MESEA!

In post-pandemic reality, Islamic investors worldwide will face an unprecedented challenge to proceed with existing portfolios and financially manage ongoing dispute resolution proceedings. The consequences of such arbitration proceedings may spiral the financial and liquidity crises for many investors. As one of South East Asia's and as an Organisation of Islamic Cooperation ("OIC") active member State, Malaysia must innovate and adapt to lead a feasibility test of Third-Party Funding ("TPF") for the first time focused on Islamic Investors. This webinar provides an overview of TPF in Malaysia, existing mechanisms towards TPF in OIC's member states, Shariah perspective on TPF under Islamic principles, and the endless possibilities for TPF Funders to invest in a modern asset class specifically aimed at Islamic investors and the Islamic Finance sector. The panellists will endeavour to set forth the important factors that may affect the Islamic investors from the Middle East, Africa, South Asia and South-East Asia.
