What is ASAM?

The use of mediation and arbitration to resolve international (and domestic) commercial disputes is becoming increasingly popular in Indonesia and other parts of the Asia-Pacific region. This is because individuals are recognizing that resolving disputes through mediation and arbitration is good for business. Both have a reputation for being cost effective and time efficient.

Further, parties generally comply with mediated outcomes of disputes and arbitral awards. Many countries also allow their national courts to enforce foreign arbitral awards. Often times this is much easier to do than to enforce a judgment of a foreign court. A mediator can also work to achieve an outcome to a dispute that all parties are in agreement with. From a long-term perspective, he/she also help the parties to resume their commercial relationship. This is critical as maintaining business relationships are vital to good business.

There is significant room for more parties to use mediation and arbitration to resolve commercial disputes. The ASAM will provide companies and businesses in Indonesia and the region with the opportunity to learn more about these methods and how they can be beneficial. The ASAM will bring together leading mediator and arbitrators from Indonesia and the region to lead discussions on a range of topics.

The symposium is an annual event and therefore an opportunity for participants to meet every year to discuss developments and their experiences in mediation and arbitration.

The objective of the symposium is to enhance participants' understanding of mediation and arbitration and promote their use of these dispute resolution methods to effectively and efficiently resolve commercial disputes.
